# NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ 0.478690 per \$100 valuation has been proposed by the governing body of Chambers County Public Hospital District No. 1.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Chambers County Public Hospital District No. 1 from the same properties in both the 2019 tax year and the 2020 tax year.
